

Volunteer Release and Waiver of Liability Form 2025

This Release and Waiver of liability (the "release") executed on (Date) _____ by (Name of Volunteer Candidate) _____ ("volunteer"), Team /Division Name _____ releases Colorado Springs Baseball, LLC (CSB), organized and existing under the laws of the State of Colorado and each of its directors, officers, employees, and agents. The Volunteer desires to provide volunteer services CSB and engage activities related to serving as a volunteer: Head Coach, Assistant Coach and Score Keeper

Volunteer understands that the scope of Volunteer's relationship with CSB is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer, that CSB will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as result of Volunteer's services to CSB.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless CSB and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to CSB. I understand and acknowledge that this Release discharges CSB from any liability or claim that I may have against CSB with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to CSB or occurring while I am providing volunteer services.

2. Insurance: Further I understand that CSB does not assume any responsibility for or obligation to provide me with financial or other resistance, including but not limited to medical, health or disability benefits or insurance of any nature in the event of my injury, illness, death or damage to my property. I expressly waive any such claim for compensation or liability on the part of CSB beyond what may be offered freely by CSB in the event of such injury or medical expenses incurred by me.

3. Medical treatment: I hereby Release and forever discharge CSB from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a Volunteer with CSB.

4. Assumption of Risk: I understand that the services I provide to CSB may include activates that may be hazardous to me including, but not limited to: COVID-19, Injuries from baseballs, bats, baseball equipment...etc. involving inherently dangerous activates. As a volunteer, I hereby expressly assume the risk of injury or ham form these activities and Release CSB from all liability from injury, illness, and death or property damage resulting from the services I provide as volunteer or occurring while I am providing volunteer services.

5. Photographic release: I grant and convey to CSB all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by CSB in connection with my providing volunteer services to CSB.

6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and that this Release shall be governed by and interpreted in accordance with the laws of the State of Colorado. I agree that in the event that any clause or provision of this Release is deemed invalid, that enforceability of the remaining provisions of this Release shall not be affected.
